


His advices was not from office it self but from the field operation in the estate.

- 1. At 1st, MSPO was voluntary and we presume that we could proceed for the 17 estates and 3 mills based on long-term certification.
- 2. MSPO Certification is mandatory, as announced in February 2017 by the Honorable Minister Datuk Seri Mah Siew Keona.

PUTRAJAYA: The Plantation Industries and Commodities Ministry has set the timeline for the Malaysian Sustainable Palm Oil (MSPO) certification mandatory compliance to up to Dec 31, 2019 with the aim to uplift the industry to global standard.

Its Minister Datuk Seri Mah Siew Keong said the compliance would be implemented in stages with plantation players that were certified with Roundtable on Sustainable Palm Oil (RSPO) to comply with the MSPO certification by Dec 31, 2018.

- 8. Improve compliances by meeting all legal and regulatory requirement.
